

The International Foundation for Therapeutic and Counselling Choice

THE 10 POINTS in summary

- Banning 'conversion therapy' infringes human rights and freedoms, imperilling both therapeutic choice and pastoral, professional and parental rights. See paragraphs 1-6 of the Review Document.
- Professional bodies promoting discriminatory monocultural viewpoints prevent ideological diversity and critique. See paragraphs 7-8 of the Review Document.
- 'Mostly-heterosexuals', the largest non-heterosexual minority group, are being denied therapeutic support to affirm their heterosexual aspirations. See paragraphs 9-11 of the Review Document.
- O4 Sexual fluidity happens in both directions but this is being ignored. See paragraphs 12-17 of the Review Document.
- Banning 'conversion therapy' will extend 'cancel culture', silence dissent and inhibit free speech. See paragraphs 18-25 of the Review Document.
- Political aspirations sacrifice much needed therapy for children and adults who feel distress about their sex. See paragraph 26 of the Review Document.
- O7 'Conversion therapy' bans are unsafe while potential causal links between trauma and same-sex attractions and 'gender dysphoria' remain unexamined. See paragraph 27 of the Review Document.
- Change-allowing therapies do not actually cause 'harm' or increase suicidality according to peer-reviewed research.
 See paragraphs 28-31 of the Review Document.
- O9 Torture claims in 'conversion therapy' are unsubstantiated and are designed to silence dissent. See paragraphs 32-36 of the Review Document.
- 10 Church leaders conceding to unsafe 'conversion therapy' bans defame and undermine the potentially complementary roles of pastoral and professional counselling. See paragraphs 37-39 of the Review Document.

The IFTCC Concensus Statement

The IFTCC affirms Biblical morality and the Christian faith and understands the damaging effects of homosexuality and gender incongruence on the image of God. As clinical practitioners, researchers, pastoral care workers, professionals, and lay-people, IFTCC extends psychological and spiritual healing that strengthens and supports disciples of Christ and those from other faith backgrounds or no faith at all.

We gather to proclaim Biblical anthropology according to the teachings of Jesus Christ and **affirm that-**

- humanity, in the diversity of two distinct, yet complementary biological sexes, male and female, are created uniquely and intentionally to bear God's image together on earth.¹
- Christ blesses the covenant of marriage and its bodily consummation only between one man and one woman and prohibits every sexual union outside this marital covenant.² Therefore, by this teaching
- chastity outside marriage validates the dignity of the human body and celibacy is a unique spiritual gift of dedication to God only as it aligns with Biblical anthropology.³
- the Biblical mandate for Christian leaders reflects this anthropology.⁴
- that sexuality, marriage, and the family it creates are essential elements of God's command to be fruitful and multiply but have been corrupted and distorted by sin.⁵ Therefore, the Christian faith offers to all people Christ's healing, restoration, and reconciliation to glorify God and declare the hope of Christ's coming kingdom.
